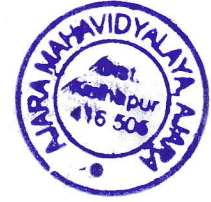

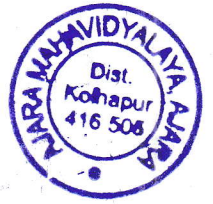

The first meeting of CDC was held on Monday dated 18/10/2021 at 9.00 a.m. in the Janata Education Society office, Ajara.

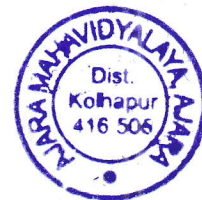

9. To sanction the Earn and Medical leaves of the staff.

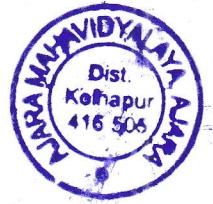
It was suggested by to sanction all the leaves with approval.
